THE MANNER OF APPOINTMENT OF VICE-CHANCELLOR TO THE SRI VENKATESWARA VETERINARY UNIVERSITY, TIRUPATI - AMENDMENT TO THE CLAUSE 5(2) OF FIRST STATUTES APPROVED.

- 2. From the Vice Chancellor Lr.No. 13493/SC/2010, dt. 17-7-2010.

In the letter second read above, the Vice Chancellor Sri Venkateswara Veterinary University, Tirupati has informed that the Board of Management, Sri Venkateswara Veterinary University, Tirupati in its meeting held on 16-7-2010 has proposed to amend Clause 5(2) of First Statutes and sought approval of the Government for the said amendment by the Board of Management.

2. The draft amendment to the Clause 5(2) of the First Statutes proposed by the Board of Management, SVVU is as follows :

AMENDMENT

In the First Statutes of Sri Venkateswara Veterinary University, Tirupati for Clause 5(2), the following shall be substituted, naemly.

"(2) Whenever a vacancy of Vice Chancellor is to be filled, the Chancellor shall ask the Board to suggest a panel of three persons who in its opinion are suitable for appointment as Vice Chancellor and the Chancellor may appoint any one person from the panel, who in his opinion is suitable for appointment as Vice Chancellor.

Provided that if the Chancellor considers that the names suggested by the Board are not suitable for appointment, he may appoint any person who in his opinion is suitable for appointment as Vice Chancellor".

3. In the circumstances reported by the Vice Chancellor, Sri Venkateswara Veterinary University, Tirupati in the letter second read above and after careful consideration of the matter, Government, hereby accord approval to the above said amendment as required under sub-section (2) of Section 42 of Sri Venkateswara Veterinary University Act, 2005 (Act 18 of 2005).

4. The Vice Chancellor SriVenkateswara Veterinary University, Tirupati shall take further necessary action accordingly.
