ORDER:-

The Government vide references 4th cited, have accorded permission for recruitment of (256) Veterinary Assistant Surgeons to fill up the vacant posts of Veterinary Assistant Surgeon in the State through the Departmental Selection Committee (DSC) duly following the Rule of Reservation and provisions of the Presidential order by giving paper notification and obtaining applications from the Veterinary Graduates as per the Guidelines issued vide reference 3rd cited.

2. In the reference 6th cited, paper notification was issued inviting applications from the Veterinary Graduates stipulating 15/12/2018 for receipt of applications.

3. The Selection Committee constituted vide G.O. 3rd cited, have completed the process of Selection of Veterinary Graduates, with reference to the Resolutions submitted by the Veterinary Graduates for appointment to the Post of Veterinary Assistant Surgeons in Animal Husbandry Department under Section-4 (b) and (c) of A. P. Regulation of appointment to public service and Rationalization of staff pattern and pay structure Act, 2 of 1994.

4. Accordingly, under Rule 10 (a) of A.P. ORDER:-

The Government vide references 4th cited, have accorded permission for recruitment of (75) Veterinary Assistant Surgeons to fill up the backlog post of Veterinary Assistant Surgeon reserved for SC and ST in the State through the Departmental Selection Committee (DSC) duly following the Rule of Reservation and Provisions of the Presidential order by giving paper notification and obtaining applications from the Veterinary Graduates as per the Guidelines issued vide reference 3rd cited.

2. In the reference 5th cited, paper notification was issued on 14-01-2020 inviting applications from the Veterinary Graduates stipulating 31/01/2020 as last date for receipt of applications.

3. The Selection Committee constituted vide G.O. 3rd cited, have completed the process of Selection of Veterinary Graduates, with reference to the Bio-data submitted by the Veterinary Graduates for appointment to the post of Veterinary Assistant Surgeons in Animal Husbandry Department under Section-4 (b) and (c) of A. P. Regulation of appointment to public service and Rationalization of staff pattern and pay structure Act, 2 of 1994.

4. Accordingly, under Rule 10 (a) of A.P. State and Subordinate Service Rules 1996, read with Rule (3) of Special Rules for A.P.A.H Service, issued vide reference 1st cited, the Veterinary Graduates whose details are appended in the Annexure enclosed to this proceedings are hereby temporarily appointed as Veterinary Assistant Surgeons in the Category (4) of Class-B of A.P.A.H Service under Backlog Recruitment, in the time Scale of Rs. 35120-950-36070- 1030-39160-1110-42490-1190-46060 1270-49870-1360-53950 - 1460- 58330-1560-63010-1660-67990-1760-73720-1880-78910- 2020 -84970- 2160-87130,

with usual allowances, subject to the condition that their services are liable to be terminated at any time, without prior notice and assigning any reasons there for.

5. The appointment of these candidates is exempted from Public Service and Rationalization of staff pattern and pay structure Act 2 of 1994.

6. They are allotted to the Joint Directors of Animal Husbandry concerned noted against their names in column (6) of the enclosed Annexure.

7. These orders of appointment are also being **dispatched to the candidates concerned by Registered Post on 11/02/2020. The time allowed to join duty under Rule 11 (a) of A.P. State and Subordinate Service Rules, 1996 is (30) days** from the date of dispatch of the appointment orders. 


