Orders have been issued in respect of the statutes prescribing the manner of appointment, powers and duties of the Heads of the Departments vide ref.1st cited.

As per the decision taken by the Board of Management at its 9th meeting held on 17.05.2008, the statute in respect of manner of appointment of University Head of Department has been placed before 4th meeting of the Academic Council held on 13.06.2008 for review of the Statues in question as desired by the Board of Management vide its Resolution No.170. Accordingly, the Academic Council has resolved to amend the statutes vide its Resolution No.80, dt.13.06.2008.

Again, the recommendations of Academic Council have been placed before the Board of Management at its 10th meeting held on 24.06.2008. The Board of Management has approved the amended proposals recommended by the Academic Council with slight modifications vide its Resolution No.196, dt.24.06.2008.

The approved amendment proposals have been sent to the Government vide ref.3rd cited for approval to amend the statues relating to the manner of appointment of Heads / University Heads of the Departments approved by the Board of Management as per the powers vested under sub section (5) and (3) of Section 42 of SVVU Act, for which, the Government have approved the proposals in toto vide ref.4th cited.

The matter has been carefully examined and as per the powers vested under sub-section (5) and (3) of Section 42 of SVVU Act, 2005, the Board of Management of SVVU hereby issues the following amendment to the statutes prescribing manner of appointment of University Head of the Departments, communicated vide Proc.No.2169/SC/2006, dt.12.09.2007.

1. Manner of Appointment of University Head of Departments:	1. Manner of appointment of Heads of Departments / University Heads of Departments:

<p>a) Where there is one professor in a department of all the constituent colleges having concerned departments, he shall be the Head of the Department.</p> <p>b) Where there are more than one directly recruited Professors, in constituent colleges having concerned departments, the senior among them shall be the Head of the Department.</p> <p>c) Where there are a directly recruited Professor and one or more CAS Professors in any department, the directly recruited Professor shall be the Head of that Department.</p> <p>d) Where there are one or more Professors, who are all CAS, the first appointed Professor shall be the Head of that Department, till a directly recruited Professor joins the department.</p> <p>e) Where there is no Professor, but there is an Associate Professor in any department, the Associate Professor shall be the officiating Head of that Department till a regular Professor joins.</p> <p>f) Where there are two or more Associate Professors in any department one of the directly recruited senior Associate Professors may be appointed as the officiating Head of that Department till a regular Professor joins.</p> <p>g) Where there is no directly recruited Associate Professor and there are CAS Associate professors, the first appointed Assoc. Professor may be the officiating Head of the Department till a regular Professor joins.</p> <p>h) Where there is neither a Professor nor an Associate Professor in any department, the Vice-Chancellor may nominate any other teacher as the Head of the Department or make such arrangements as he may consider appropriate. The senior Assistant Professor in the college will take the responsibility of the activities in each of the college Departments.</p>	<p>a) Where there is one Professor in a Department of all the constituent Colleges having concerned Departments, he shall be the Head / University Head of the Department.</p> <p>b) Where there are more than one Professor (CAS / directly recruited) in constituent colleges having concerned Departments, the senior-most among them shall be the Head / University Head of the Department.</p> <p>c) Deleted.</p> <p>d) Deleted.</p> <p>e) Where there is no Professor but there is an Associate Professor in any Department, the Associate Professor shall be the officiating Head / University Head of the Department till a Professor joins.</p> <p>f) Where there are two or more Associate Professors (CAS / Directly recruited) in any Department, the senior-most Associate Professor shall be declared as officiating Head / University Head of that department till a Professor joins.</p> <p>g) Deleted.</p> <p>h) Where there is neither a Professor nor an Associate Professor in any Department, the Vice-Chancellor may nominate any other teacher as the Head of the Department or make such arrangements as he may consider appropriate. The Senior Assistant Professor in the concerned Department will take the responsibility of the activities in each of the concerned college Departments.”</p>
