As per the reference 1<sup>st</sup> cited UGC has communicated the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023 vide reference 2<sup>nd</sup> cited to formulate a simplified and effective mechanism for students grievance redressal. In this regard UGC has also informed to appoint a ombudsperson at University level for redressal of grievances of students referred to University.

In this regard Dr.I.Sankara Reddy, Retired Professor and Ex-Associate Dean of College of Dairy Technology, Tirupati is appointed as Ombudsperson of Sri Venkateswara Veterinary University, Tirupati for a period of three years or until he attains the age of 70 years whichever is earlier from the date of assuming office and shall be eligible for re-appointment for another one term.

For conducting the hearings, the ombudsperson shall be paid sitting fee. The ombudsperson shall be allowed compensation in the form of a fee Rs.2,250/-(Rupees Two thousand two hundred and fifty only) per sitting with maximum upper limit as Rs.45,000/- (Rupees Forty five thousands only) per month. The sitting means per day functioning, irrespective of number of cases handled and its duration in terms of working hours. The frequency of sitting by ombudsperson shall be need based and cannot be fixed. The ombudsperson will be paid TA/DA at rates admissible to Class-I Officers of the State Government.

The above expenditure of honorarium and TA & DA for Ombudsperson of SVVU appointed for students Grievances Redressal Committee (SGRS) shall be met from the Head of Account "150500- Direct Receipts – 1005 – Miscellaneous".

The sitting of ombudsperson is need based and ombudsperson will be called as and when the complaints are received from the Colleges. The sitting charges will be submitted after the ombudsperson is called for sitting. As and
