The Prof., & Head of LFC, NTR CVSc., Gannavaram is hereby permitted to engage and utilize the services of 4 workers on outsourcing basis @ Rs.8,330/- P.M plus all statutory payments i.e. ESI+EPF and GST etc., through the approved Contractor of the Zone for a period of 175 days from the date of engagement. The expenditure may be met from the Man power of the project Head of account and instructed that no additional funds will be provided by the University. After expiry of 175 days the proposals may be send to the University for further approval.

Sanction is hereby accorded to the Prof., & Head of LFC, NTR CVSc., Gannavaram for an amount of Rs.10,000/- (Rupees Ten thousand only) as Permanent Advance for meeting the petty cash expenses of the project head of account with instructions to settle the same on or before closure of the project.

The Prof., & Head of LFC, NTR CVSc., Gannavaram is hereby permitted to purchase of consumable items in the rate contract approved by the University if not available required items Tenders/ quotations shall be called as per University procedure.

The Prof., & Head of LFC, NTR CVSc., Gannavaram is hereby instructed to follow the rules and regulations and other terms and conditions of the Project as stipulated in the project and purchases have to be made for items duly following University purchase procedures in vogue.

After completion of the project the Prof., & Head of LFC, NTR CVSc., Gannavaram is directed to submit the completion report to the Funding Agency i.e. Indian Oil Corporation Limited, Hyderabad and copy of the same to the University for office record.
